**SVC POLICY:**

SVC requires that authors of papers that SVC plans to publish, in print, or electronically, transfer and assign the copyright to SVC. If, after transferring the copyright to SVC, an author would like to distribute larger quantities of his/her work, grant permission to another organization or publication to use the work, or is unsure whether his/her intended use is permitted, the author should seek permission from the SVC. *This signed statement must be returned to the SVC for the paper to be considered for publication. The intent of this Agreement is to protect the interests of both the SVC and authors/employers and to specify reasonable rights for both parties related to publication and reuse of the material.*

**COPYRIGHT DEFINED:**

Copyright to an original work belongs to the author who created the work unless the author transfers or assigns the copyright to another party. The copyright holder has the legal right to decide who may reproduce, publish, distribute or otherwise use the work. An original work, such as a written paper, presentation slides, and the audio and video of the presentation, may be protected by copyright. You cannot, however, copyright a fact or idea.

The undersigned hereby transfers copyright ownership to the Society of Vacuum Coaters (SVC) in the above-titled paper (referred to as "Paper" in this agreement). The assignment gives SVC the right to register copyright to the paper in its name as claimant and to publish the paper in any print or electronic medium.

**Authors (or their employers, in the case of works made for hire), retain the following rights:**

1. All proprietary rights other than copyright, including patent rights.
2. The right to make and distribute limited copies of the Paper for noncommercial purposes.
3. The right to post a reprint of the Paper on an internet site controlled exclusively by the author/employer, provided that (a) the Paper is made available to users without a fee or charge; (b) the posting is after the official date of publication of the SVC Conference Proceedings; and (c) the following statement appears on the first page, or screen, of the Paper as posted on the web site:

4. The right to use the Paper for educational (lecture or classroom) purposes.
5. The right to prepare derivative publications based on the Paper, including books or book chapters, journal papers, and magazine articles, provided that publication of a derivative work occurs subsequent to the official date of publication of the SVC publication in which the Paper appears and SVC is appropriately referenced. A derivative work must be different enough from the original to be regarded as a "new work".

**WHO SHOULD SIGN?** This form must be signed by at least one author. If not signed by all authors, the author(s) signing this Agreement represents that he/she is signing this Agreement as authorized agent for and on behalf of all the authors.

By signing this Agreement, the authors warrant that (1) the Paper is original and has not previously been published elsewhere; (2) this work does not infringe on any copyright or other rights in any other work; (3) all necessary reproduction permissions, licenses, and clearances have been obtained; and (4) the authors own the copyright of the Paper, are authorized to transfer it, and have full power to enter into this Agreement with the SVC.
